

REGULATIONS EYBIS.com-EVENT

ART 1. DEFINITION "EYBIS.com-Event"

"EYBIS.com-Event" is a meeting of motorcyclists to have free racing sessions on the circuit.

ART 2. ORGANISATION – USE OF IMAGES

- The organisation is the responsibility of "EYBIS" (www.eybis.com). Every participant and/or visitor engages to follow strictly all regulations of the organising team.
- The organisation has the right to post – without any accountability of the participants – photographs and/or video's of the event on the website of EYBIS.com.

ART 3. ADMITTED VEHICLES AND DRIVERS

All motorcycles that are in good technical condition, especially concerning a good suspension, adapted tyres, brakes in perfect working condition and without oil leaks.

Only registered drivers have access to the circuit with a motorcycle. Loaning a motorcycle to a not registered person is strictly forbidden. Offenders are responsible for eventual accidents and have no rights against the persons, mentioned in the articles 1 to 5 of the document about the yielding of accountability. On top of that, offenders are immediately excluded of further participation of the event. On the track, it is NOT allowed to take passengers on the motorcycle.

ART 4. EQUIPMENT AND LINE OF CONDUCT

The participant has to wear a full leather suit (except for the participants in the beginners group that can also wear a suit in other fabrics like gore-tex, cordura, etc.) and a certified helmet, boots and gloves.

Every form of competition is excluded ! All participants should drive with respect for all the other drivers. Every participant that is considered dangerous by the organisation, will be excluded of further participation. There is no remedy against this. No organisational vehicle (ambulance, towtruck, outrider,...) can be overtook as long as it is on the track.

ART 5. IDENTIFICATION PARTICIPANTS – WRISTLET

The motorcycle of every participant will get – after successfully having passed the technical inspection – a sticker that serves as entryticket for the track. Every participant has to wear the wristlet and has to show it on demand by the organisation.

ART 6. ACCESS TO THE TRACK

The spectators are not allowed along the track, unless those with a specific permit like photographer, cameraman, etc.

ART 7. ALCOHOL – DRUGS

The participant commits himself not to drive under influence of alcoholic beverages or any other drug. Abuses will be sanctioned with immediate exclusion from any further participation.

ART 8. DAMAGE – THEFT

The organisation can in no way be held responsible for damaged or stolen material.

ART 9. FORCE MAJEURE

In case of temporary or definitive cancellation of the trackday because of force majeure, (accident, oilcleaning, electricity break-down, weather conditions, changed environmental licence, ...), the organisation cannot be held responsible.

The participants cannot claim repayment from the organisation.

ART 10. CANCELLATION

Participants cannot cancel their registration, but do have the possibility to transfer their participation on to someone else. Candidates that are refused because the session is booked up, will be fully refunded. The money will be paid on the accountnumber they specified.

I yield every accountability on ground of articles 1382 to 1386 bis of the Civil Code, and for every damage, as well material as moral.

I also declare to have noted the regulations of the organisation and commit myself to these without any reserve.
